**Acute:** May cause respiratory tract irritation. May be harmful if swallowed. Ingestion is not an expected route of entry in industrial or commercial uses.

**Chronic:** IARC has designated titanium dioxide (TiO<sub>2</sub>) as Group 2B – possibly carcinogenic to humans in dust form. However, a number of long term animal studies and human epidemiology studies evaluating TiO<sub>2</sub> and workplace exposure show insufficient evidence for carcinogenic effects. EPA, NTP and OSHA do not designate TiO<sub>2</sub> as a carcinogen and ACGIH designates TiO<sub>2</sub> as A4 - not classifiable as a human carcinogen. Mortality from other chronic diseases, including other respiratory diseases, was not associated with exposure to TiO<sub>2</sub> dust.
